ORDINANCE #1-0-12

**AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH
OF WANAQUE, TITLED "ALCOHOLIC BEVERAGES"**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF
WANAQUE, COUNTY OF PASSAIC AND STATE OF NEW JERSEY AS FOLLOWS:**

Section 1. Paragraph 47-17.3 is hereby amended a follows

Consumption in Public Areas

A. Definition. As used in this Article, the following words shall have meanings indicated.

PUBLIC AREA

1. Public parks, playgrounds, trails, paths, and other recreational areas, owned, leased or controlled by the Borough of Wanaque or by any other governmental bodies.
2. Other public and semi-public open spaces, including but not limited to public streets, sidewalks, parking lots, garage ways, walkways, and rest areas.
3. Scenic and Historic Sites.
4. Other public building and structures.

Section 2. Paragraph 47-17.3 (b) is hereby revoked.

Section 3. Paragraph 47-10 A&B, is hereby revoked

Section 4. Article 7-27 Title Consumption or Possession by underage persons prohibited; acceptions, is hereby revoked

Section 5. Paragraph 47-28 Exceptions (new)-Any person, or organization, desiring to serve or consume alcoholic beverages in any public area, is above described, shall first obtain an

appropriate club license, or other license, approved and issued by the new Jersey Division of Alcoholic Control. Any such person or organization in connection with the issuance of any such license, shall be required to provide a policy of liability insurance, or an endorsement on a liability insurance policy, naming the Borough of Wanaque as an additional insured in connection with the consumption or distribution of alcoholic beverages as aforesaid in a minimum amount of One Million Dollars (\$1,000,000).

Section 6. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 7. This Ordinance shall take effect after notice and publication as provided by law.
