**ORDINANCE NO: 14-0-12**

**AN ORDINANCE AUTHORIZING THE VACATION OF AN EASEMENT FROM THE  
NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION IN CONNECTION  
WITH THE REALIGNMENT OF WEST BROOK ROAD IN THE BOROUGH OF  
WANAQUE, NJ  
PURSUANT TO THE LOCAL LANDS AND BUILDINGS LAW  
N.J.S.A. 40A:12-1 et seq.**

**WHEREAS**, the County of Passaic has designed the replacement of West Brook Road Bridge over the Wanaque Reservoir calling for the vacation of the existing bridge and its replacement on a new alignment designed to lessen the roadway curvature approach to the bridge; and

**WHEREAS**, upon completion of the replacement bridge project, there will be an unneeded access easement portion of West Brook Road which should be returned to the North Jersey Water Supply Commission; and

**WHEREAS**, the Borough of Wanaque will be receiving from the North Jersey Water Supply Commission, an easement permitting access across the replacement and redesigned West Brook Road Bridge.

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF  
THE BOROUGH OF WANAQUE, COUNTY OF PASSAIC AND STATE OF NEW  
JERSEY AS FOLLOWS:**

1. In connection with the replacement of the West Brook Road Bridge over the Wanaque Reservoir and it's realignment to lessen the roadway curvature of the West Brook Road approach to the bridge the Borough of Wanaque will be receiving an easement from the North Jersey

District Water Supply Commission for the replacement bridge. In consequence thereof, the unneeded excess portion of the existing easement with the North Jersey District Water Supply Commission must be vacated.

2. The Borough of Wanaque is hereby authorized to vacate the unneeded access portion to the existing West Brook Road Bridge in exchange for an easement from the North Jersey District Water Supply Commission granting an easement an easement for the utilization of the replacement bridge.

3. The vacation of the excess existing easement, after the replacement of West Brook Road Bridge as aforesaid, is in the best interests of the citizens and taxpayers of the Borough of Wanaque.

4. The Borough of Wanaque is hereby authorized through its' officials, to enter into such agreement and sign such documents, as being necessary to carry out the purpose of this project to vacate the unneeded excess portion of the existing easement for the West Brook Road Bridge over the Wanaque Reservoir.

5. The easement to be vacated is set forth and identified under Schedule "A" annexed hereto.

6. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

7. This Ordinance shall take effect upon final adoption and publication as provided by law.
