AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF WANAQUE,  
CHAPTER 108, VEHICLES AND TRAFFIC, TO AMEND SCHEDULE XII – LEFT  
TURN PROHIBITIONS

BE IT ORDAINED AS FOLLOWS:

Section 1. That Section 108-24.1 of the Code of the Borough of Wanaque, Schedule XII  
– Left turn prohibitions, be amended to read as follows:

108-24.1 Schedule XII- Left Turn prohibitions.

In accordance with the provisions of section 108-13.2 no person shall make a left-  
hand turn at the following described locations:

Ringwood Avenue northbound into driveway at Block 430, Lots 9-13, also known  
as 1067-1077 Ringwood Avenue (Haskell Towne Center)

From the driveway at Block 480, Lots 9-13, also known as 1067-1077 Ringwood  
Avenue (Haskell Towne Center) onto Ringwood Avenue northbound.

Ringwood Avenue southbound into driveway at Block 438 Block 1.01, also  
known as 1102 Ringwood Avenue (CVS)

From both driveways at Block 464, Lot 40, also known as 1353 Ringwood  
Avenue (strip mall) onto Ringwood Avenue northbound.

Ringwood Avenue southbound at the intersection of Burnside Place, 8:00 a.m. to  
9:00 a.m. and 3:00 p.m. to 4:00 p.m. /school days.

Section 2. Any ordinance inconsistent with this ordinance is hereby repealed, but only to  
the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption and publication according  
to law.
