**CAPITAL ORDINANCE**

**AN ORDINANCE OF THE BOROUGH OF WANAQUE, LOCATED IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, CANCELLING CERTAIN CAPITAL PROJECT BALANCES TO CAPITAL SURPLUS AND REAPPROPRIATING SAME AS AN IMPROVEMENT AUTHORIZATION FOR THE CONSTRUCTION OF A NEW MUNICIPAL BUILDING (INCLUDING FACILITIES FOR THE POLICE DEPARTMENT AND COURT), AND FURTHER APPROPRIATING THE SUM OF \$299,630 AVAILABLE IN THE TRUST ACCOUNT UNDER THE CAPTION OF “RESERVE FOR REDEVELOPMENT”, AS AN IMPROVEMENT AUTHORIZATION, FOR THE CONSTRUCTION OF A NEW MUNICIPAL BUILDING (INCLUDING FACILITIES FOR THE POLICE DEPARTMENT AND COURT).**

**WHEREAS**, the Borough of Wanaque is embarking on the construction of a new municipal building, including the construction of a new Police Department and Court, and

**WHEREAS**, certain unused capital project balances, in the sum of \$425,000, are reflected on the records of the Borough of Wanaque, which the Borough Council finds it appropriate and necessary to re-appropriate these balances for the construction of a new municipal building, and

**WHEREAS**, there exists a “Reserve for Redevelopment” in the Trust Fund of the Borough of Wanaque in the sum of \$299,630, as reflected on the records of the Borough of Wanaque, which the Borough Council finds it appropriate and necessary to re-appropriate these balances for the construction of a new municipal building.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Wanaque in the County of Passaic and State of New Jersey as follows:

1. Unused capital project balances in the sum of \$425,000 as reflected on the records of the Borough of Wanaque, and included in Schedule A attached hereto, are hereby cancelled to Capital Surplus in the General Capital Fund and Appropriated as an Improvement Authorization entitled:

“Construction of New Municipal Building--\$425,000”

2. The Reserve for Redevelopment is hereby transferred from the Trust Fund to the General Capital Fund and is hereby Appropriated as an Improvement Authorization entitled:

“Construction of New Municipal Building--\$299,630”

{ This appropriation may be used as a down payment to be applied to the cost of the improvement authorization. }

3. This Ordinance does not authorize the issuance of any debt.
4. This Ordinance shall take effect immediately upon its final passage and publication according to law.
5. All ordinances or parts of ordinances or resolutions that are in conflict with the provisions of this Ordinance are repealed to the extent necessary.
