AN ORDINANCE TO AMEND THE SALARY ORDINANCE  
OF THE BOROUGH OF WANAQUE FOR THE YEAR 2011

WHEREAS, the Borough of Wanaque is undergoing a revaluation of property within the Borough; and the Tax Assessor has negotiated a stipend for the additional work during the period of the revaluation; and

WHEREAS, the Borough Council of the Borough of Wanaque has agreed to this amount for a limited period of time;

NOW, THEREFORE, be it ordained by the Borough Council as follows:

Section 1. That the salary ordinance of the Borough of Wanaque for 2011 be amended to add the following:

Tax Assessor – additional \$1000 per month in addition to the regular salary, for the period beginning April 1, 2011 and ending no later than March 31, 2012.

Section 2. Any ordinance inconsistent with this ordinance is hereby repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption, approval, and publication according to law, and shall be retroactive to April 1, 2011.
