AN ORDINANCE APPROPRIATING \$68,175 FROM CAPITAL SURPLUS AND \$56,825 FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF EQUIPMENT FOR THE DEPARTMENT OF PUBLIC WORKS

BE IT ORDAINED by the Governing Body of the Borough of Wanaque, County of Passaic, New Jersey, as follows:

- Section 1. The improvement described in Section 3 of this ordinance is authorized and declared to be necessary and useful for municipal improvements.
- Section 2. There is hereby appropriated for said purposes the sum of\$ 68,175 FROM THE Capital Surplus Fund and \$68,825 from the Capital Improvement Fund for a total of \$125,000.
- Section 3. That the purchase of equipment for the Department of Public Works (backhoe) is a necessary improvement and capital expense for the Borough of Wanaque.
- Section 4. This ordinance shall take effect upon final adoption and publication according to law.




