**ORDINANCE NO: 13-0-12**

**AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF AN EASEMENT FROM  
THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION IN CONNECTION  
WITH THE REALIGNMENT OF WEST BROOK ROAD IN THE BOROUGH OF  
WANAQUE, NJ  
PURSUANT TO THE LOCAL LANDS AND BUILDINGS LAW  
N.J.S.A. 40A:12-1 et seq.**

**WHEREAS**, the County of Passaic has designed the replacement of West Brook Road Bridge over the Wanaque Reservoir calling for the vacation of the existing bridge and its replacement on a new alignment designed to lessen the roadway curvature approach to the bridge; and

**WHEREAS**, in order to complete the replacement project, the acquisition of an easement from the North Jersey District Water Supply Commission to the Borough of Wanaque is necessary; and

**WHEREAS**, the realignment will provide enhanced alignment, of the existing bridge, and enhance the vehicular safety.

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF  
THE BOROUGH OF WANAQUE, COUNTY OF PASSAIC AND STATE OF NEW  
JERSEY AS FOLLOWS:**

1. The Borough of Wanaque is hereby authorized to enter into an easement with the North Jersey District Water Supply Commission to permit access to a replacement West Brook Road Bridge over the Wanaque Reservoir as set forth on Exhibit "A" annexed hereto.

2. The acquisition of the easement by the Borough of Wanaque from the North Jersey District Water Supply Commission, is authorized pursuant to the local lands and buildings law, N.J.S.A.40A:12-1 et seq

3. The Borough of Wanaque deems it to be in the best interests of the citizens and taxpayers to implement the replacement of the existing West Brook Road Bridge over the reservoir in order to lessen the roadway curvature so as to provide for more safe and expeditious traffic flow, across the bridge.

4. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

5. This Ordinance shall take effect upon final adoption and publication as provided by law.
