**AN ORDINANCE AUTHORIZING THE ACQUISITION OF
REAL ESTATE KNOWN AS BLOCK 232; LOT 4 ON THE WANAQUE TAX
MAP AND FURTHER IDENTIFIED AS 569 RINGWOOD AVENUE, WANAQUE, NJ
PURSUANT TO THE LOCAL LANDS AND BUILDINGS LAW
N.J.S.A. 40A:12-1, et seq.**

WHEREAS, the Borough of Wanaque, is embarking upon a project to build a new municipal building by utilizing the present property owned by it at 579 Ringwood Avenue together with other contiguous properties; and

WHEREAS, in order to acquire additional properties necessary for such project, the Borough deems it necessary to acquire property known as Block 232, Lot 4, known as 569 Ringwood Avenue, Wanaque, NJ; which premises are owned by John Maiello and grace Maiello, his wife; and

**NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF
THE BOROUGH OF WANAQUE, COUNTY OF PASSAIC AND STATE OF NEW
JERSEY AS FOLLOWS:**

1. Thomas Carroll, Business Administrator is hereby authorized to enter into a Real Estate Contract for the purchase of real estate, known as Block 232, Lot 4, 569 Ringwood Avenue, Wanaque for the purchase price of \$285,000 subject to the approval of the Wanaque Borough Attorney, Anthony Fiorello, Esq. The Contract, for the purchase of said real estate in the amount \$285,000, shall be subject to the approval of bonding and bonds to be issued by the Borough of Wanaque in an amount sufficient to acquire title to the premises.

2. Mayor Daniel Mahler or Thomas Carroll, Business Administrator are hereby authorized, together with the Borough Attorney, Anthony Fiorello, Esq. to close title to the premises and execute such closing documents, and instruments that may be necessary for the Borough to obtain title to the above referenced property.
3. The form of Contract and addendum is annexed hereto.
4. The Borough of Wanaque deems it to be in the interest of the citizens and tax payers of the Borough of Wanaque to acquire title to the property, known as Block 232, Lot 4 and commonly known as 569 Ringwood Avenue so that it may complete the acquisition of property necessary to construct a new Borough municipal building.
5. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
6. This Ordinance shall take effect upon final adoption and publication as provided by law.
