ORDINANCE #10-0-13

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF WANAQUE, CHAPTER 108, "VEHICLES AND TRAFFIC" TO RESTRICT PARKING DURING CERTAIN HOURS ON A PORTION OF RHINESMITH AVENUE.

WHEREAS, the Borough of Wanaque is undertaking the construction of a new Municipal Building, which will result in the temporary closure of the ingress driveway to the existing building; and

WHEREAS, it will be necessary to enter the Municipal Building parking lot from Rhinesmith Avenue during the construction period of approximately two years; and

WHEREAS, the Police Department has recommended that parking be restricted on the east side of Rhinesmith Avenue during the weekday to facilitate traffic flow.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. That Chapter 108-15, Schedule 2, No Parking Certain Hours, be amended to add the following:

Name	Side	Days	Hours	Location
Rhinesmith Avenue	East	Monday Tuesday Wednesday Friday Thursday	8 a.m to 5 p.m. 8 a.m. to 10 p.m.	From Pellington Street to Cross Street

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall become effective upon final adoption and publication according to law.
