“WATER” TO CLARIFY THE EFFECTIVE DATE

BE IT ORDAINED AS FOLLOWS:

Section 1. That Section 3 of Ordinance #15-0-12 “Water” adopted on June 11, 2012 be and is hereby amended to read as follows:

This Ordinance shall take effect for water readings taken on or after January 1, 2013, and shall be applicable to the entire water consumption for that reading period.

Section 2. Any Ordinance inconsistent with this Ordinance is repealed, but only to the extent of such inconsistencies.
