ORDINANCE #3-0-14

AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF WANAQUE,  
CHAPTER 91, "SEWERS" TO AMEND THE SCHEDULE OF RATES FOR THE  
CONNECTION FEE

BE IT ORDAINED by the Governing Body of the Borough of Wanaque as follows:

Section 1. That Section 91-1 of the Code of the Borough of Wanaque be amended to read as follows:

91-1. Schedule of rates, rents and charges.

The schedule of rates, rents and charges for services provided by the Wanaque Sewer Utility be established as follows:

- A. Residential User Fee - \$860.00 per annum, payable quarterly
- B. All other Users fee - \$10.75 per thousand gallons of water used, payable quarterly. The minimum quarterly charge shall be \$215.00.
- C. Connection fee - The sewer connection fee for each new service unit - \$10,654.00
- D. Temporary Non-Occupancy of Multi-EDU and single EDU Buildings - \$75 per EDU per quarter.

Section 2. Any ordinance inconsistent with this ordinance is hereby repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption and publication according to law.
