AN ORDINANCE APPROPRIATING \$450,000 FOR THE RECONSTRUCTION OF SANITARY SEWER LATERALS AND SANITARY SEWER MAINS ON JACKSON STREET, MILTON PLACE, CRESCENTE LANE AND RINGWOOD AVENUE IN THE BOROUGH OF WANAQUE, UTILIZING FY 2013 CDBG GRANT OF \$100,000, AND AUTHORIZING EXPENDITURE OF \$350,000 FROM THE SEWER UTILITY CAPITAL FUND

BE IT ORDAINED AS FOLLOWS:


Section 1. That the following funds be appropriated and authorized for expenditure for the replacement of the sanitary sewer lines and laterals on Jackson Street, Milton Place, Crescente Lane and Ringwood Avenue (laterals only) in the Borough of Wanaque:

FY 2013 Passaic County CDBG	\$100,000
Sewer Utility Capital Fund	<u>\$350,000</u>
TOTAL	\$450,000

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption and publication according to law.
