BE IT ORDAINED AS FOLLOWS:


Section 1. That ordinance 26-0-16 adopted on December 12, 2016 setting forth the salaries for employees of the Borough of Wanaque, be amended as follows to adjust the maximum salary for certain positions:

Public Safety Telecommunicator trainee	\$49,000	2/1/17

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.


