ORDINANCE #11-0-16

AN ORDINANCE AMENDING CHAPTER 133, ARTICLE 4, OF THE CODE OF THE BOROUGH OF WANAQUE TITLED "ANIMALS AND RABIES CONTROL" AND REGULATING FARM ANIMALS, FOWL, PIGEONS POISONOUS SNAKES AND REPTILES IN THE BOROUGH OF WANAQUE AND PROVIDING PENALITIES FOR VIOLATION

BE IT ORDAINED by the Mayor and Council of the Borough of Wanaque, County of Passaic, State of New Jersey, as follows:

- Section 1. That Chapter 133-34 B be amended to read as follows:
- B. No person shall own, be the guardian of, or keep or harbor more than three (3) dogs or cats in total within the Borough of Wanaque, except for properly licensed kennels, pet shops, shelters or pounds, and except for new born and unweaned dogs or cats, which may be kept for up to ninety (90) days after weening. The total number of dogs or cats shall not exceed three (3) for any one household within the Borough of Wanaque notwithstanding the number of owners or guardians residing in said household.
- Section 2. That any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistency.
- Section 3. This ordinance shall take effect upon final adoption and approval according to law.
