
AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF  
WANAQUE, CHAPTER 67A CONSTRUCTION CODES, UNIFORM,  
ARTICLE III, FEES TO PROVIDE FOR THE WAIVER OF FEES NOT TO  
EXCEED \$1,000.00 FOR NOT-FOR-PROFIT ORGANIZATIONS

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WANAQUE  
that Article III of Chapter 67A Construction Codes, Uniform of the Code of the Borough of  
Wanaque shall be amended to include a new Section 67A-12 as follow:

67A-12 Waiver of Fees for Non-Profit and Not-For-Profit Organizations

The fees described in Section 67A-10 above shall be waived, in an amount not to exceed  
\$1,000.00 for any twelve (12) month period, for organizations that have been granted non-profit  
or not-for-profit status by the United States Internal Revenue Service (IRS). Waiver shall be  
requested in writing to the Construction Code Official which shall include proof of non-  
profit/not-for-profit status.




