**AN ORDINANCE AMENDING CHAPTER 116 B-1 OF THE CODE OF THE BOROUGH OF WANAUKE  
TITLED DOGS TO BE LEASHED**

**WHEREAS**, issues have arisen concerning the requirement for leashing dogs in public and semi-public areas; and

**WHEREAS**, there is a need to clarify the manner of leashing of such dogs.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WANAUKE, PASSAIC COUNTY, NEW JERSEY AS FOLLOWS:**


**1. Chapter 116 B-1, titled Dogs to be Leashed, is hereby amended as follows:**


No person owning, harboring, keeping, or in charge of any dog, shall allow, or permit, such dog to go upon the lawn, yard, entranceway, or driveway, of any private residence, without the permission of the owner thereof, or upon any public streets, or in any public places, or semi-public areas of multiple dwelling complexes within the Borough, or in any public parks, play areas, or school premises, except the Municipal Dog Park, unless such is accompanied by a person, and is securely confined and controlled by an adequate, physical leash. This shall exclude electronic leashes, electronic shock collars, or any other electrical, radio wave, or anything not physically attached from the dog to the owner or person in charge thereof.


