
AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF  
WANAQUE, CHAPTER 28 PERSONNEL, MUNICIPAL, ARTICLE X  
BOROUGH ADMINISTRATOR

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WANAQUE  
that Article X Borough Administrator of Chapter 28 Personnel, Municipal be amended to include  
a new Section 28-63 as follows:

28-63 Full Time Mayor

- a. In the absence of a full-time Administrator, the Borough Council may adopt a Resolution to authorize the Mayor to earn a full-time salary due to the increased demands and responsibilities that fall on the Mayor due to said absence. When authorized by the Borough Council the Mayor will be responsible for all of the powers and duties of the Administrator described in section 28-60 above and in any other sections of the Code of the Borough prescribing additional duties and powers to the Administrator provided they do not conflict with the Office of the Mayor.
- b. The full time designation shall only apply when the Mayor receives a Resolution from the Borough Council authorizing the Mayor to act and to assume wherever permissible by law the responsibilities of the Administrator. This shall be considered a full-time position of the municipality and will include but not be limited to a full-time work week and availability during regular Borough business hours. There shall be no further compensation or overtime for additional hours or work-related activities.




