
BE IT ORDAINED AS FOLLOWS:

Section 1. That Chapter 108-15, Schedule II of the Code of the Borough of Wanaque be amended to delete parking Restrictions on Rhinesmith Avenue between Pellington Street and Cross Street.

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon adoption, approval, and publication according to law.
