ORDINANCE #23-0-16

AN ORDINANCE TO AMEND CERTAIN SECTIONS OF THE CODE OF THE BOROUGH
OF WANAQUE AS IT RELATES TO FEES FOR PERMITS

BE IT ORDAINED AS FOLLOWS:

Section 1. That the sections of the following Chapters of the Code of the Borough of Wanaque be amended to read as follows:

Chapter 66, Car Lots, Used. 66-5. Annual License Fee. The annual license fee for such license shall be \$300 per year.

Chapter 87, Peddlers and Solicitors. 87-5. Display of license and identification tag; annual license fee; expiration of license. B. The fee for the issuance of such a license shall be \$100.00


Chapter 87, Peddlers and Solicitors. Ice Cream Vendors. 87-13 Permit Required; annual fee. No mobile ice cream and ice cream products vendor shall operate within the Borough of Wanaque without a permit to do so. For each mobile vendor of ice cream and ice cream products, the annual permit fee shall be \$200.

Chapter 11. Vehicles, Towing and Storage of. 118-8. Fees. The following schedule of nonrefundable fees is adopted for the obtaining of a towing license. A. Application fee :\$200. B. License Fee \$100 per year, payable before January 1 of the license year. For a temporary license for a period of less than 12 months, the fee shall be prorated on a monthly basis.

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption, approval, and publication according to law.




