AN ORDINANCE AMENDING CHAPTER 94, SOIL REMOVAL, OF THE MUNICIPAL  
CODE OF THE BOROUGH OF WANAQUE

**WHEREAS**, Chapter 94, Soil Removal, of the Municipal Code of the Borough of Wanaque establishes, rules and regulations, regarding the moving of soil on property located within the Borough; and

**WHEREAS**, Chapter 94 does not include a minimum volume after which a soil removal permit is needed; and

**WHEREAS**, the Mayor and Council of the Borough of Wanaque deem it to be in the best interest of the residents of the Borough to modify Chapter 94 in order to establish minimum soil volumes.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Wanaque that Chapter 94, Soil Removal, of the Municipal Code of the Borough of Wanaque is hereby amended as follows:

1. Section 94-1, Permit for moving in soil, shall be amended to read:

No developer, excavator or other person shall move, or cause, allow, permit or suffer any soil exceeding fifteen (15) cubic yards from, in or upon any lot in the Borough of Wanaque, unless and until a soil permit shall first have been issued by the Mayor and Council of the Borough of Wanaque.

2. Section 94-2, Permit required for soil removal, shall be amended to read:

No owner of any lot in the Borough of Wanaque shall cause, allow, permit or suffer any soil in or upon such lot exceeding fifteen (15) cubic yards to be moved, by any developer, excavator or other person, until such developer, excavator or other person has first obtained a soil permit therefor.




