ORDINANCE #8-0-14

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF WANAQUE, CHAPTER 29, PERSONNEL POLICIES AND REGULATIONS, TO ADD SECTION 29-10, METHOD OF COMPENSATION

BE IT ORDAINED AS FOLLOWS:

Section 1. That Chapter 29 of the Code of the Borough of Wanaque, Section 10, Method of Compensation, be amended to add the following:

29-10 F. Direct Deposit

In accordance with NJSA 52:14-15a et. seq. (PL 2013, C 28), all employees of the Borough of Wanaque, with the exception of temporary or seasonal employees, shall have their net pay directly deposited in a specific banking institution based on information provided by the employee.


29-10 G. Internet access

Information concerning net pay deposited in accordance with section 20-10F shall be made available to the employee through a secured internet site provided by the Borough's payroll provider. W-2 and other payroll information will also be provided through the secured internet site.

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect with the payroll dated July 11, 2014.
