

1. Pursuant to NJSA 40a:12-4, et seq. the Borough of Wanaque hereby authorizes and confirms the grant of a deed of easement for sidewalk maintenance on premises known as Lot 24, Block 460, 164 Greenwood Avenue, Wanaque, New Jersey, annexed hereto as Exhibit A.






