

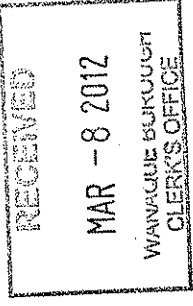



**RESOLUTION PROVIDING FOR INCREASE IN
RESERVE FOR UNCOLLECTED TAXES PERCENTAGE**

WHEREAS, the Borough of Wanaque collected only 97.97% of the 2011 taxes due to an increase in State and County tax appeals as a result of unfavorable economic conditions in the local economy and real estate markets for 2011, and

WHEREAS, the lower percentage collected in 2011 has an effect on the "Reserve for Uncollected Taxes" in 2012, and

WHEREAS, the Governing Body is desirous of reducing the 2011 total tax levy by the amount of the tax appeals in calculating the 2011 tax collection percentage resulting in a collection percentage of 98.20% for 2011, and


WHEREAS, the Governing Body desires to anticipate 98.19% collection for 2012, to help reduce the "Reserve for Uncollected Taxes", with prior written consent of the Director of Local Government Services,

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Wanaque, County of Passaic, State of New Jersey, that the prior written consent of the Director of Local Government Services be requested to anticipate 98.14% collection of taxes in 2012 in figuring the "Reserve for Uncollected Taxes".

BE IT FURTHER RESOLVED that two certified copies of this resolution be forwarded to the Office of the Director of Local Government Services.
