ORDINANCE 14-0-13

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF WANAQUE, CHAPTER 108, ENTITLED "VEHICLES AND TRAFFIC," TO AMEND SECTIONS 108-7 AND 108-7.1 REGARDING WEIGHT LIMITS.

BE IT ORDAINED AS FOLLOWS:

Section 1. That Chapter 108, sections 7 and 7.1 be amended to read as follows:

**§ 108-7 Vehicles over four tons excluded from certain streets.**

Trucks in excess of the manufacturer's gross weight of four tons are hereby excluded from the streets or parts of streets described in Schedule V, § [108-18](#), except for the pickup and delivery of materials on such streets, said Schedule V being attached to and made a part of this chapter.

**§ 108-7.1 Vehicles over six tons excluded from certain streets.**

**A.**

It shall be unlawful for any person to operate any motor vehicle in excess of the manufacturer's gross weight of six tons, in either direction, on Conklintown Road, in the Borough of Wanaque, County of Passaic, and State of New Jersey with the exception of municipal vehicles or vehicles performing municipal services or for the pickup and delivery of materials or providing services for local residents or local residents who reside in the immediate area of Conklintown Road and must utilize said road to access their premises.

**B.**

Any person convicted of a violation of this ordinance shall be liable, through a penalty, and pay a fine of not less than \$50 nor more than \$250 or imprisonment in the county jail not exceeding 15 days or a period of community service not exceeding 30 days, or any or either of the aforesaid penalties.

Section 2. Any ordinance inconsistent with this ordinance is repealed, but only to the extent of such inconsistencies.

Section 3. This ordinance shall take effect upon final adoption and approval according to law.
